Strategically located where I-35W and I-35E merge, Forest Lake is effectively the gateway to Northern Minnesota and offers easy access to both Minneapolis and St. Paul in 25 minutes. The City serves as a regional hub, meeting the retail and service needs of the surrounding area. This multigenerational community is thoughtful about growth and development as well as visioning and implementing opportunities.



The City of Forest Lake is home to a combination of strong retail centers, a robust business park, a quaint and welcoming downtown situated on a lake, and a wide array of services that support the growing population and expanding businesses – all surrounded by an abundance of natural beauty.

BUSINESS & DEVELOPMENT

Forest Lake recognizes the importance of supporting existing industries while offering new areas for economic growth. With a downtown plan in place, efforts in that area are focused on creating a specific identity to promote the downtown. Providing new opportunities for commercial, industrial, and manufacturing operations in new or expanded business parks and mixed use areas is also a high priority. Forest Lake supports efforts in rural areas to expand entrepreneurial activities that are compatible with the rural character. Residents want to maintain and expand the City of Forest Lake's standing as a regional center or "hub," developing a strong, economically diverse downtown and commercial corridors that support the needs of residents and attracts visitors from around the region.

Compared to neighboring communities, Forest Lake has the highest number of employees and the most employment establishments. There are approximately 7,000 jobs in the City of Forest Lake and roughly 500 employment establishments. With their convenient location just north of the 35W/35E split, they are also able to provide convenient access for commuters traveling to Minneapolis and St. Paul.

Over 7,600 households call Forest Lake home, and with abundant available land, Forest Lake is poised for robust future housing growth. In fact, the Metropolitan Council anticipates that Forest Lake will grow by 40 percent over the next 20 years.

The City of Forest Lake has put the following goals in place that provide the basis for development and redevelopment strategies and reflect the values and goals City residents and other stakeholders view and hold important. These include protecting natural resources, providing for parks and recreation opportunities, guiding the use of land and managing growth, planning for an effective transportation system, and creating and expanding opportunities for economic growth.





HEALTHCARE

Allina Health is a nonprofit health system that cares for individuals, families, and communities throughout Minnesota and western Wisconsin. With 12 hospital campuses, 60+ primary care clinics, and 20 same-day and urgent care centers, Allina Health employs 28,500 staff members and 8,300 expert providers. Forest Lake is home to the Allina Health Forest Lake Clinic, Allina Health Minneapolis Heart Institute – Forest Lake, and the Courage Kenny Rehabilitation Institute – Forest Lake making access to healthcare a priority for the community.

Twin Cities Orthopedics (TCO) Forest Lake with Urgent Care provides prompt and specialized attention for acute injuries. Open seven days a week, the facility offers a walk-in clinic with advanced diagnostic tools and cutting-edge therapy techniques.

M Health Fairview Mental Health Clinic - Forest Lake offers mental health and addiction care.

EDUCATIONAL OPPORTUNITIES

The City of Forest Lake is part of Independent School District 831 (Forest Lake Area Schools). District 831 serves all or parts of the Cities of Columbus, East Bethel, Forest Lake, Ham Lake, Hugo, Lino Lakes, Marine on St. Croix, Scandia, Stacy, and Wyoming, as well as Linwood and May Townships. The district includes seven elementary schools, one 7-8th grade middle school, a senior high, and an alternative learning center, of which all but five of the elementary schools are located in the City of Forest Lake.

Additional academic institutions in Forest Lake include St. Peter Elementary School (a private Catholic school), Lakes International Language Academy (a Mandarin Chinese and Spanish immersion charter school), and the North Lakes Academy (a grades 5-12 public charter school).





RECREATIONAL ACTIVITIES

The City of Forest Lake offers a variety of attractions, year-round recreational opportunities, shopping, dining, and lodging, making it the perfect place for a day trip, a weekend stay, or as a base to explore the northern Twin Cities, scenic St. Croix Valley, and Minnesota's Lakes Region.

Forest Lake is a full-service community, home to many facilities enjoyed and used by the public. The Washington County Library is valued by residents and students for its literary and research amenities. Recreational facilities include the Forest Lake YMCA, three golf courses, and its many parks, lakes, local and regional trails. The parks and trails system currently consists of 23 parks, 18 open spaces, and a trail system comprised of nearly 16 miles of total trail connections. The Hardwood Creek Regional Trail runs through the center of the Forest Lake along Highway 61. The trail travels through Hugo and Forest Lake as it connects to the Bruce Vento Regional Trail in the south, providing access to many other metro area trails. The trail also connects to the Sunrise Prairie Trail in Chisago County in the north and the Glacial Hills Regional Trail search corridor. This trail is open to biking, hiking, in-line skating, snowshoeing, and cross-county skiing. The parallel turf trail is open to horseback riding in the summer and snowmobiling.

The City operates two lighted ice hockey rinks during the winter, located in Tower Park. The City also operates an open outdoor skating rink at Beltz Park. Year-round swimming, classes, and other activities are also available for residents at the YMCA.

One of the state's oldest and largest Fourth of July celebrations is hosted in Forest Lake, complete with a carnival, bingo tent, street vendors, a huge parade, spectacular fireworks and more. In addition, the area also hosts outstanding farmers markets, arts and musical events.





THE ORGANIZATION

The Forest Lake City Council is composed of a Mayor and four Council members who are elected at large. The Mayor serves a two-year term of office, and the Council members serve four-year staggered terms. The City Council legislates for the City and sets administrative policy.


The Administration Department is responsible for providing general administrative services to ensure the implementation of City Council action, policies, and directives. The department also encourages City development, positive communications, and maintenance of a strong park system.

City boards and commissions include the Airport Commission, Economic Development Authority, Parks and Recreation Commission, and the Planning Commission.


The organization currently employs approximately 69 full-time and part-time staff members. There are also a number of temporary and seasonal workers as well as volunteer firefighters.

The Forest Lake City Center opened in 2014, bringing all of the City's Police, Fire, Administration, Building, and Zoning Departments together under one roof. The building also features a second level with a large community room and outdoor deck.

CORE DUTIES OF THE POSITION

- Plans, organizes, and directs City affairs to ensure a coordinated and efficient effort to meet the goals and objectives established by the City Council and various Boards and Commissions.
- Monitors operations to ensure compliance with applicable laws, regulations, rules, policies, and ordinances.
- Establishes goals, programs, and objectives and prepares reports to the City Council.
- Prepares operations and capital budgets including recommendations for tax levies and utility rates and submits to the City Council for consideration.
- Monitors City budgets throughout the year for compliance and financial viability.
- Performs analyses and administers long-term finance alternatives including bonds, T.I.F. monies and investments.
- Oversees the preparation of ordinances, resolutions, and policies for City Council consideration and implementation.
- Implements, interprets, and applies City Council actions, directives, and policies.
- Attends and participates in all City Council, EDA meetings, and various special meetings involving the City's development, as needed.
- Interacts directly with the public to communicate the goals and priorities of the City Council, solicits feedback on City issues, and resolves concerns.
- Administers planning, zoning, development, and redevelopment issues including code compliance, development agreements, public financial assistance recommendations and activities for community enhancement.
- Negotiates and implements City contracts including labor contracts.
- Represents management in negotiating collective bargaining agreements and attends and supervises labor management committee meetings.
- Analyzes wage and salary reports and data to determine a competitive compensation plan.
